**Tuition for the 2010-2011 school year will be paid:**

\_\_\_\_\_ **One payment:** One payment is due on or before June 1, 2010. (There is a \$175.00 discount.)

\_\_\_\_\_ **Two payments:** Two payments are due on June 1, 2010 and December 15, 2010. The first semester payment is due on or before June 1, 2010 and the second semester payment due on or before December 15, 2010. There is an additional \$25.00 annual handling fee for this payment option.

\_\_\_\_\_ **Four payments:** Four payments are due on June 1, 2010, September 1, 2010, January 15, 2011, and April 1, 2011. There is an additional \$50.00 annual handling fee for this payment option.

\_\_\_\_\_ **Monthly Payment Plan:** Twelve monthly payments beginning in June 2010 and ending in May 2011. This plan will be handled through FACTS. (\$41.00 family account fee, payable directly to FACTS), \$96.00 interest fee, payable monthly at \$8.00 per month. A down payment may be made in order to minimize the required monthly payment.

Payments may be made by Visa or Mastercard and will have a 2.5% fee added for the credit card transaction.

In consideration of the acceptance of this reservation by St. Vincent - St. Mary High School and St. Vincent - St. Mary High School reserving a place in the grade as indicated, the undersigned agrees to pay in full the required annual tuition and other charges as may be incurred. I understand that my obligation to pay all tuition and other charges for the full academic year is unconditional and that no portion of such charges so paid or outstanding will be refunded or cancelled notwithstanding the subsequent absence, withdrawal, or dismissal of the student from St. Vincent - St. Mary High School.

**It is further agreed that enrollment, as specified within this Reservation and Tuition Agreement, may be cancelled in writing by the parent or guardian (directed in writing to the Business Office), without damages (except forfeiture of any reservation deposit) if received in the Business Office prior to June 1, 2010. If enrollment is not cancelled in writing before June 1, 2010, parents or guardians financially responsible for students are obligated to pay the full tuition and other charges.**
