LOGAN STIEBER: *Monroeville HS* – 4x OHSAA State Champ. *The Ohio State University* – 4x Big Ten Champion; 4th wrestler in [NCAA](#) history to win 4 individual National Championships. Led the OSU to their first team wrestling National Championship in school history. Stieber finished his NCAA career with a record of 119-3. *International competition* - 2016 61kg Freestyle World Champion; 2018 65kg Freestyle World Cup Champion; 2018 65kg Freestyle Pan American Champion.

KOLLIN MOORE: *Norwayne HS* – OHSAA State Champ. 51-0 as a senior. *The Ohio State University* - NCAA Finalist (2019); All-American (2017, 2018, 2019); Big Ten Champion (2017, 2018); Big Ten Finalist (2017, 2018, 2019); Third Place at NCAA Championships (2017); Big Ten Freshman of the Year (2017); Cliff Keen Las Vegas Invitational Champion (2017)

JOHNNI DIJULIUS: *Walsh Jesuit HS* – 4x OHSAA Finalist; 3x OHSAA State Champ. *The Ohio State University* – 4x NCAA Tournament Qualifier; 4x Big Ten Tournament placer: 4th, 5th, 6th, 7th. Currently a resident athlete at the Ohio Olympic Regional Training Center.
